Chairman Gleason called the November 17, 2014, Racine County Economic Development and Land Use Planning Committee public hearing and committee meeting to order at 6:00 p.m. He introduced the committee and staff and explained public hearing and meeting procedures. Conditional Use to construct a ±3859 sq.-ft. addition to the existing Town of Burlington Fire Station #2, to include creating/expanding a driveway entrance on Fish Hatchery Rd. to accommodate 13 new parking stalls and elimination of the driveway entrance and parking area on McHenry St.; 7211 McHenry St. (CTH "P"); Sec. 18, T2N, R19E, **Town of Burlington** (Parcel Id. No. 0020219032000)

Brian Jensen reviewed the petition and public hearing testimony using text, maps and slides.

The addition will expand the current fire station. The proposal includes elimination of the access to McHenry Street and widening the existing access on Fish Hatchery Road. The access onto Fish Hatchery Road is a better alternative, as this is a lesser traveled road with lower speed limits. Surrounding land use and zoning districts were identified.

Jon Wallenkamp, Kueny Architects, was present and answered questions from the committee.

STAFF RECOMMENDATION(S)

Staff recommends approval of this petition.

This use appears to be permitted by underlying zoning and, based on other things going on in the area, the proposed addition, expansion of the entrance with a new parking area, and the elimination of the McHenry Street access creates a more safe access that is in the interest of the community.

Conditional Use to continue a sand and gravel extraction operation; 29606 Durand Avenue; Sec. 26, T3N, R19E, **Town of Burlington** (Parcel Id. 002031926010000)

Jensen reviewed the petition and public hearing testimony using text, maps and slides.

This is the annual two-year permit renewal. Surrounding land use and zoning districts were identified. Twenty-seven (27) acres are currently active and four (4) acres have been reclaimed, including a pond and wetlands. Racine County Land Conservation staff visited the site and determined that the quarry is operating in compliance with previous approvals. There have been no complaints about this operation.

Jon Wanasek was present and answered questions from the committee.

STAFF RECOMMENDATION(S)

The financial assurance bond is current. Land Conservation staff inspected the site and determined that the quarry is operating in compliance with previous approvals. Staff recommends approval of this petition.
