#### #2a - Sheriff's Office - Courthouse Security Plan

The meeting was turned over to Sheriff Chris Schmaling. Sheriff Schmaling distributed the Courthouse Security Plan handout. This plan will basically mirror the layout of the Law Enforcement Center. The public entrance would be restricted to Wisconsin Avenue and the doors from the College Avenue entrance will be closed off. An employee entrance will be accessed from the lower level on the south side of the building. More panic alarms will be placed throughout the courthouse and those placements will be confidential. Discussion was held regarding the need for a sidewalk running from the College Avenue side of the courthouse around to the public entrance on Wisconsin Avenue. The cost for the sidewalk is approximately \$15,000. As previously mentioned, this need will continue to be monitored. Phase II of this project will involve camera installation and will be discussed with the committee at a later date.
