#4 – Sheriff Schmalig reported on the Parental Internet Monitoring Software

The Sheriff gave an informative report on the use and need for the Parental Internet Monitoring software. Software will help concerned parents to be alerted when their child is doing questionable things on their social media such as Facebook and Twitter. They will be purchasing the smallest quantity of 1,000 at \$5.90 per unit with funds from the Crimes Prevention Account. They also will be working with Best Buy and Barnes & Noble to host a community event and seek donations to recover some of the cost. He will be putting together a packet which will contain the DVD and information for parents to deal with situations that could arise from use of the software.
