1. Call to Order, Roll Call

2. Public Comments

3. Approval of the January 23, 2014, Summary Minutes

4. Review, discussion and possible action concerning removal of the pavilion at River Bend Nature Center

Julie Anderson and Dave Prott proposed putting this project online for bidding. In the event of no bids coming in, county crews would demolish the structure.

First reading will occur on March 25, 2014. Motion carried unanimously. VOTE: 5/0

9. Review, discussion and possible action on a proposal for GRAEF-USA to provide professional services for preparation of a stability analysis of the Rochester Dam
