ORDINANCE BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE AMENDING SECTION 12-72 OF THE RACINE COUNTY CODE OF ORDINANCES RELATING TO NO PARKING ZONES

To the Honorable Members of the Racine County Board of Supervisors:

The Racine County Board of Supervisors do ordain as follows:

Section 12-72 of the Racine County Code of Ordinances relating to no parking zones on County Highway "G" is hereby amended to read as follows:

Sec. 12-72. No parking zones enumerated.

(2) County Trunk Highway G.

- a. No parking at any time on the south side of CTH "G" beginning at a point three thousand one hundred seventy (3,170) feet west of the centerline of CTH "V" westerly for a distance of two hundred eighty-five (285) feet.
b. No parking at any time on either side of CTH "G" from its intersection with STH "32" easterly to a point three hundred seventy-five (375) feet east of its intersection with Chester Lane.
c. No parking at any time on the east side of CTH "G" from its intersection with Three Mile Road southerly to a point one hundred thirty (130) feet south of its intersection with Saxony Drive.
d. No parking at any time on the west side of CTH "G" from its intersection with Three Mile Road southerly to its intersection with Saxony Drive.

Section 12-72 of the Racine County Code of Ordinances relating to no parking zones on County Highway "A" is hereby amended to repeal Ordinance 99-33 and allow parking on County Highway "A" as follows:

- ~~a. No parking on the south side of CTH A from a point three hundred (300) feet east of the centerline of STH 45 to a point three hundred (300) feet west of the centerline of STH 45.~~
~~b. No parking on the north side of CTH A from a point three hundred (300) feet east of the centerline of STH 45 to a point three hundred (300) feet west of the centerline of STH 45.~~
