**ORDINANCE BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE  
AMENDING SECTION 14-86, ENFORCEMENT AND PENALTIES, CHAPTER 14, OF  
THE RACINE COUNTY CODE OF ORDINANCES RELATING TO UNAUTHORIZED  
OCCUPANCY; FAILURE TO REMIT MARINA SLIP FEES**

To the Honorable Members of the Racine County Board of Supervisors:

The Racine County Board of Supervisors do ordain as follows:

Section 14-86 of the Racine County Code of Ordinances relating to unauthorized occupancy; failure to remit marina slip fees is hereby amended to read as follows:

**Sec. 14-86. Enforcement and penalties.**

(c) Unauthorized occupancy; failure to remit marina slip fees.

(1) No person shall park, stop or leave standing, whether attended or unattended, any vessel or watercraft of any kind:

a. in any slip or mooring at Reef Point Marina without written authorization from Reef Point Marina staff; however, in cases of emergency, written authorization within 24 hours is satisfactory; or

b. in any manner contrary to terms of slip contract or posted rules and regulations; or

c. in any manner as to block, obstruct, or limit the use of the harbor or the Reef Point Marina thoroughfares; or

d. without full payment of slip fee on or before vessel or watercraft is moored.

(2) The penalty for violation of subsection (1) above shall be a forfeiture of not less than two hundred dollars (\$200.00) or more than the outstanding balance for the seasonal rental of the slip or mooring occupied.
