25 **East, Township of Burlington, County of Racine, State of Wisconsin, that is**
26 **currently zoned A-2 General Farming and Residential District II.**

28 **The official Racine County Zoning Map is hereby amended to conform to this**
29 **ordinance.**

31 **The Racine County Clerk is directed to transmit duplicate copies of this**
32 **ordinance by registered mail to the Burlington Town Clerk within seven (7) days**

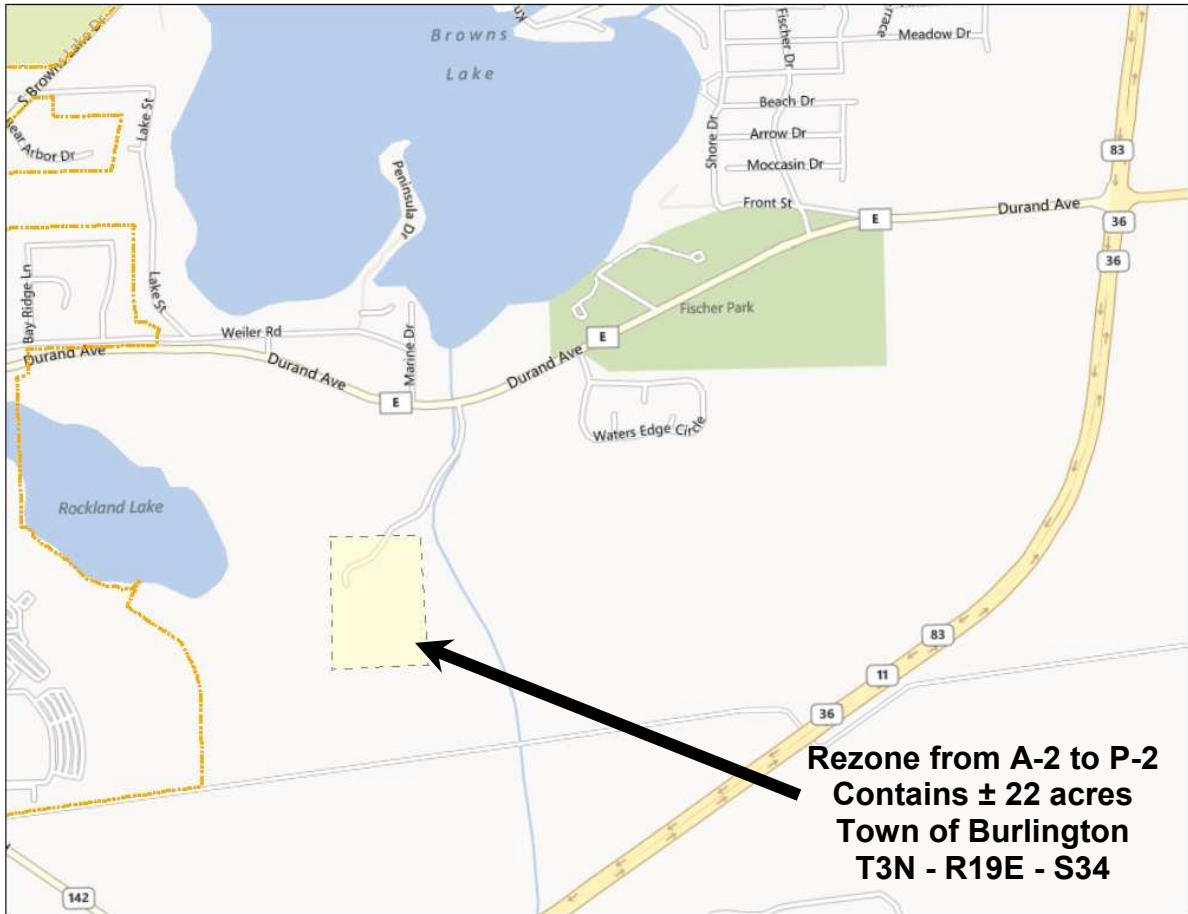
