ORDINANCE BY THE RACINE COUNTY ECONOMIC DEVELOPMENT & LAND USE PLANNING COMMITTEE TO REZONE FROM A-2 GENERAL FARMING & RESIDENTIAL

DISTRICT II TO B-3 COMMERCIAL SERVICE DISTRICT

SECTION 1, T3N, R21E, TOWN OF YORKVILLE

APPLICANT: TCTS, LLC
