## ORDINANCE ADOPTING THE MULTI-JURISDICTIONAL COMPREHENSIVE PLAN **FOR RACINE COUNTY: 2035**

The County Board of Racine County, Wisconsin, does ordain as follows:

- Section 1. Pursuant to Section 59.69 (2) and (3) of the Wisconsin Statutes, Racine County is authorized to prepare and adopt a comprehensive plan as defined in Sections 66.1001 (1) (a) and 66.1001 (2) of the Wisconsin Statutes.
- Section 2. The County Board of Racine County, Wisconsin, has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by Section 66.1001 (4) (a) of the Wisconsin Statutes.
- Section 3. Racine County has duly noticed a public hearing on the comprehensive plan and the Economic Development and Land Use Planning Committee held the public hearing, in accordance with Section 66.1001(4) (d) of the Statutes.
- Section 4. The Racine County Economic Development and Land Use Planning Committee, by a majority vote of the entire committee, has adopted a resolution recommending to the County Board the adoption of the document entitled SEWRPC Community Assistance Planning Report No. 301, A Multi-Jurisdictional Comprehensive Plan for Racine County: 2035.
- Section 5. The Racine County Board does, by the enactment of this ordinance, formally adopt the document entitled SEWRPC Community Assistance Planning Report No. 301, A Multi-Jurisdictional Comprehensive Plan for Racine County: 2035, pursuant to Section 66.1001 (4) (c) of the Wisconsin Statutes.
- Section 6. This ordinance shall take effect upon passage by a majority vote of the members-elect of the County Board and publication as required by law.
