10 The Racine County Board of Supervisors ordains as follows:

12 SEC. 5-4(b) Issuance of citations; enforcement  
13

14 (b) In addition to law enforcement officers, the following  
15 officials of the county are hereby authorized to issue citations  
16 for the provisions of this Code or ordinances specified below. Such  
17 officials may delegate this authority to designated employees:

Violation of provisions in chapter 16, article IV	Director of public works, administrator of Ridgewood Health Care Center Public works director
Violations of provisions in chapter 14	Public works director
Violations of provisions in chapters <u>12.5 and 18-21</u> <del>0</del>	Zoning administrator
Violation of provisions in chapter 16, article VI	Director of public works
Violations of section 11-20	School attendance officer appointed pursuant to W.S.A. § 118.16(1) (b)

14 WHEREAS, the State of Wisconsin has mandated that the County adopt and administer a  
15 nonmetallic mining program; and

16 WHEREAS, the nonmetallic ordinance contained in Chapter 21 of the Racine County Code  
17 of Ordinances, as adopted by Ordinance 2001-8, authorizes the issuance of citations for  
18 violations; and

19 WHEREAS, the codifier changed Chapter 21, as adopted, to Chapter 12.5, but did not  
20 modify Section 5-4 accordingly; and

21 WHEREAS, the Zoning Administrator currently is authorized to issue citations for programs  
22 run by the Planning and Development Department, such as the zoning, subdivisions and utilities  
23 ordinance.
