15 SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by
16 Ordinance 91-196.

19 follows: Amend the Racine County Zoning Ordinance and change the
20 zoning district for the following described lands from R-2 Suburban
21 Residential District (Unsewered) to R-4 Urban Residential District I

24 E, Town of Burlington, Racine County, Wisconsin.

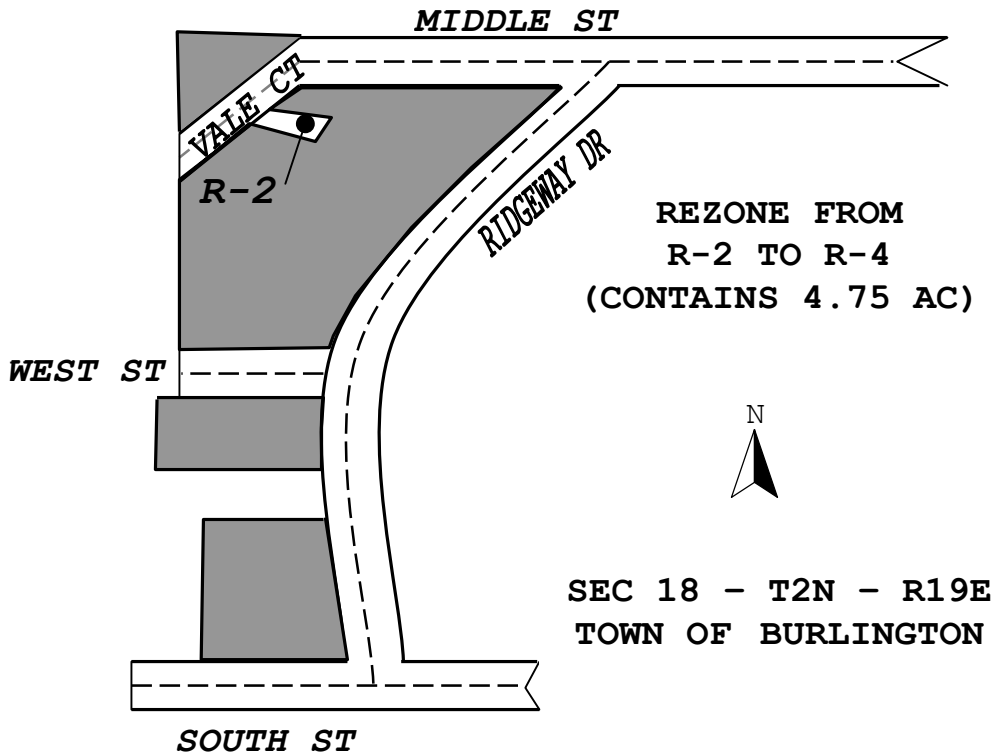
