The County Board of Supervisors of the County of Racine ordains as follows: Replace the incorrect legal description listed in Ordinance No. 2005-130 for the Jonathan & Deborah Krogh M-3 to A-2 rezoning with the following description.

THENCE south $01^{\circ}30'04''$ west for a distance of 693.00 feet, along the west line of said Northeast $\frac{1}{4}$, to a point;

THENCE south $71^{\circ}10'30''$ east for a distance of 462.31 feet, to the point of beginning;

THENCE north 08°45′57" east for a distance of 195.49 feet to a point;

THENCE north $00^{\circ}00'00''$ east for a distance of 258.80 feet to a point;

THENCE south $90^{\circ}00'00''$ east for a distance of 134.73 feet to a point;

THENCE south $00^{\circ}00'00''$ west for a distance of 500.00 feet to a point;

THENCE northwesterly along the arc of a curve to the right whose chord length is 100.00 feet and bears north 75°24′30″ west to a point;

THENCE continuing along the arc of said chord whose chord length is 54.56 feet and bears north 73°15′30″ west to a point;

THENCE north $71^{\circ}10'30''$ west for a distance of 16.88 feet to the point of beginning.
