AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

THENCE N $00^{\circ}46'08''$ W along said west line, 330.00 feet; THENCE N $89^{\circ}15'27''$ E, 1340.46 feet;

THENCE N 00°48'57" W, 99.00 feet to a point on the north line of the SE 4 of said Section 1;

THENCE N $89^{\circ}15'27''$ E along said north line, 1340.38 feet to a point on the east line of the SE 1/4 of Section 1;

THENCE S $00^{\circ}51'47''$ E along said east line, 662.60 feet;

THENCE S $89^{\circ}13'03''$ W, 1340.92 feet; N $00^{\circ}48'57''$ W, 234.53feet; S $89^{\circ}15'27''$ W, 1340.73 feet to the place of beginning.
