 AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

The County Board of Supervisors of the County of Racine ordains as follows: Amend the Racine County Zoning Ordinance and change the zoning district for the following described lands from A-1 General Farming District I & M-4 Quarrying District to A-2 General Farming & Residential District II

THENCE N 02°09′37″ W, 267.00 feet to a point;
THENCE N 87°50′23″ E, 706.35 feet to a point;
THENCE S 01°18′45″ E, 1320.66 feet to a point;
THENCE S 87°52′58″ W, 1314.41 feet to a point;
THENCE S 87°56′43″ W, 1313.06 feet to a point;
THENCE N 01°26′19″ W, 1317.54 feet to a point;
THENCE N 87°51′15″ E, 1312.50 feet to the point of beginning.

The official Racine County Zoning Map is hereby amended to conform to this ordinance.


