AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

THENCE north 00°36'54" west for a distance of 330.44 feet, along the west line of the east ½ of said ¼ Section to a point;

THENCE north 89°13'52" east for a distance of 1030.54 feet, along the south line of Blackhawk Industrial Park and said line extended to a point;

THENCE south 00°32'52" west for a distance of 155.29 feet, along the west line of the West Frontage Road, to a point;
