**ORDINANCE BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE
AUTHORIZING MODIFICATIONS TO SECTION 12-46 OF THE RACINE COUNTY
CODE OF ORDINANCES RELATING TO SPEED LIMITS**

To the Honorable Members of the Racine County Board of Supervisors:

The Racine County Board of Supervisors do ordain as follows:

Part 1

Section 12-46(11) of the Racine County Code of Ordinances relating to speed limits on County Trunk Highway "P" is hereby repealed and recreated to read as follows:

~~Forty five (45) miles per hour for all vehicles from the Racine-Kenosha County line, northerly to the south corporate limits of the City of Burlington.~~

- a. Forty-five (45) miles per hour for all vehicles from the Racine-Kenosha County line, northerly for a distance of 1.23 miles to a point 150 feet south of the centerline of South Street.
- b. Thirty-five (35) miles per hour for all vehicles from a point 150 feet south of the centerline of South Street, northerly for a distance of 0.82 miles to a point 300 feet north of the centerline of Fulton Street.
- c. Forty-five (45) miles per hours for all vehicles from a point 300 feet north of the centerline of Fulton Street, northerly for a distance of 1.81 miles to the south corporate limits of the City of Burlington.

Part 2

Section 12-46(22) of the Racine County Code of Ordinances relating to speed limits on the Rustic Road System is hereby renumbered as Section 12-46(23)

Part 3

Section 12-46(22) of the of the Racine County Code of Ordinances relating to speed limits on County Trunk Highway "L" is hereby created to read as follows:

- a. Thirty-five (35) miles per hour for all vehicles from a point 1425 feet southwest of its intersection with CTH-"O", northeasterly a distance of 0.54 miles to a point 1425 feet northeasterly of its intersection with CTH-"O".
