COMMENCE at the southeast corner of said Section 10;

THENCE north $89^{\circ}58'41''$ west for a distance of 412.50 feet, along the south line of the southeast 4 of Section 10 to a point;

THENCE north $00^{\circ}08'36''$ west for a distance of 727.90 feet, along the centerline of West River Road, to a point;

THENCE south $89^{\circ}58'42''$ east for a distance of 463.04 feet, to a point;

THENCE south $28^{\circ}13'54''$ east for a distance of 816.69 feet, to a point;

THENCE south $88^{\circ}54'06''$ west for a distance of 435.12 feet, along the south line of the southwest 4 of Section 11, to the point of commencement.

RESERVING that westerly and southerly portion utilized for public road purposes.

EXCEPTING therefrom those portions currently zoned A-2.


