RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE AUTHORIZING RELOCATION AND ACQUISITION OF RIGHT OF WAY FOR A HIGHWAY IMPROVEMENT PROJECT ON COUNTY TRUNK HIGHWAY "D" IN THE VILLAGE OF ROCHESTER, RACINE COUNTY

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that Racine County authorizes the proper improvement and maintenance of County Trunk Highway "D" requiring certain relocation or changes and authorizes the acquisition of additional right of way and easements along that portion of County Trunk Highway "D" (Washington Avenue) from Heritage Road to State Street in the Village of Rochester.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that under the authority granted by sections 32.05, 83.07, and 83.08 of the Wisconsin Statutes, the Racine County Board of Supervisors authorizes County Trunk Highway "D" to be relocated and that right-of-ways be acquired, in accordance with the relocation order attached hereto and incorporated herein as Exhibit "A", and the plat attached hereto and incorporated herein as Exhibit "B". A copy of the relocation order and plat shall be filed with the Racine County Clerk within twenty (20) days after its issue.

BE IT FURTHER RESOLVED that the Racine County Board of Supervisors authorize Corporation Counsel to prepare a contract with necessary and appropriate terms and conditions to facilitate this improvement.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Executive, the County Clerk and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.


