RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE AUTHORIZING THE COUNTY TREASURER TO CANCEL ALL UNPAID REAL PROPERTY TAXES INCLUDING INTEREST AND PENALTIES ON THE PROPERTY LOCATED AT 1425 N. MEMORIAL DRIVE

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that, pursuant to §75.105 of the Wisconsin Statutes, the cancellation of all unpaid real property taxes, including interest and penalties, up to and including through the current 2012 tax year, on the property located at 1425 N. Memorial Drive associated with the original Tax Key Parcel #276-00008250000, which was previously authorized in Res. No. 2010-33, and the current Tax Key Parcel #276-00008250001 is hereby authorized and approved if the following conditions are met:

1. The City of Racine presents satisfactory evidence to the County Treasurer in the form of a signed agreement between the City Of Racine and the Department of Natural Resources to investigate and clean up the property, and agrees to maintain and monitor the property as required under rules that the Department of Natural Resources promulgates and under any contract entered into under those rules.

2. The City of Racine agrees to be solely responsible for the 2013 taxes either through change of the parcel status to municipal property, thereby allowing for tax exempt status, or by paying the 2013 taxes less any accrued fines and penalties.

BE IT FURTHER RESOLVED that the City of Racine has provided satisfactory evidence to the County and consistent with the terms of Wis. Stat. Sec. 75.105 that:

a) the property is contaminated by a hazardous substance;

b) an environmental assessment has been conducted and concludes that the property is contaminated by the discharge of a hazardous substance;

 c) the City of Racine agrees to clean up the property by restoring the environment to the extent practicable and minimizing the harmful effects from a discharge of a hazardous substance in accordance with rules that the Department of Natural Resources promulgates.

BE IT FURTHER RESOLVED that the Racine County Board of Supervisors hereby authorizes the County Treasurer to cancel the delinquent taxes, interest and penalties as to original Tax Key Parcel #276-00008250000 and the current Tax Key Parcel #276-000082500001 through the 2012 tax year upon the City of Racine

INFORMATION ONLY

WHEREAS, the property located at 1425 N. Memorial Drive was originally described by Tax Key Parcel #276-00000825000 but the parcel was split into three parcels by a certified survey map in 2004 creating three new tax key parcel numbers 276-000008250001, 276-000008250002 & 276-000008250003.

WHEREAS, at the time of the split, the delinquent taxes, interest and penalties that accrued as to Tax Key Parcel #276-0000825000 for the years 2000-03 were not apportioned to the three newly created parcels.

WHEREAS, the Racine County Board of Supervisors previously considered and authorized the cancellation of the back taxes, specials, interest and penalties as to Tax Key Parcel #276-00000825000 in Resolution 2010-33 and at that time all three newly created parcels were current on all taxes since the split.

WHEREAS, Resolution 2010-33 was conditioned upon a 75.105 Agreement with the Department of Natural Resources (DNR) which required that the then owner of Tax Key Parcel #276-000008250001 transfer the property to the City of Racine.

WHEREAS, the owner did not transfer the property to the City of Racine as originally planned but the City of Racine has now acquired title to the property in mid-January of 2013.

WHEREAS, Racine County has unpaid real estate taxes and interest and penalties on the property located at 1425 N. Memorial Drive in the City of Racine; the unpaid real estate taxes, specials, interest and penalties currently total \$163,158.56 as to the original Tax Key Parcel #276-00000825000 and \$148,430.24 as to the current Tax Key Parcel #276-0000082500001; and

WHEREAS, an environmental assessment has concluded that the property located at 1425 N. Memorial Drive, which housed a former manufacturing facility, is environmentally contaminated by a hazardous substance; and

WHEREAS, because of the environmental contamination of the site, the County has not sought an In Rem judgment with respect to the property; and

WHEREAS, the City of Racine has now acquired this property with a view to its future economic development on the understanding that all the taxes, specials, interest and penalties on the property would be canceled; and

WHEREAS, the City of Racine has agreed to clean up the property by restoring the environment at the property to the extent practicable and minimizing the harmful

effects from the discharge of hazardous substances, consistent with state and federal law; and

WHEREAS, the City of Racine is entering into a 75.105 Agreement with the DNR that formalizes its undertaking to investigate and remediate the property; and

WHEREAS, the City of Racine has agreed for so long as it owns the property to maintain and monitor the property as required under the rules of the DNR and any contract entered pursuant to those rules; and

WHEREAS, in order to facilitate its acquisition of the property, the City of Racine has written off \$230,000.00 of delinquent water charges on the original property and has not been reimbursed almost \$75,000 in specials on the new parcel, as well as incurred other significant costs associated with the property; and

WHEREAS, the County Treasurer, the Office of the Corporation Counsel, and the Finance & Human Resources Committee have reviewed this matter; and on all of the conditions being met, all recommend that it is in the public interest to cancel all of the unpaid real estate taxes, including specials, interest and penalties on both tax key #'s 276-000008250000 & 276-000008250001, as well as the taxes, specials, interest and penalties that will accrue for the tax year 2012 in order to facilitate the City of Racine's remediation and redevelopment of the property.

The total taxes due of \$82,262.67 in general taxes and \$1,302.33 in special taxes has been written off as uncollectable.

The County does not take specials over \$7,500 so the specials on parcel 276-0000008250001 have not been paid to the City of Racine

The 2012 Tax bill is still owed to the City and will not be turned over to the County until the 2013 August Settlement.
