RESOLUTION BY THE RACINE COUNTY ECONOMIC DEVELOPMENT AND LAND USE PLANNING COMMITTEE RECOMMENDING ENDORSEMENT OF THE YEAR 2035 REGIONAL HOUSING PLAN FOR SOUTHEASTERN WISCONSIN

WHEREAS, the SEWRPC has transmitted certified copies of its resolution adopting the housing plan, together with the above-referenced SEWRPC Planning Report No. 54, to the county and local units of government of the Southeastern Wisconsin Region; and

WHEREAS, the Racine County Board of Supervisors believes that the housing plan prepared by the SEWRPC will be a valuable guide to the development of the region, as well as to the County.

NOW, THEREFORE, BE IT RESOLVED that the Racine County Board of Supervisors hereby endorses the Year 2035 Regional Housing Plan for Southeastern Wisconsin, as set forth in SEWRPC Planning Report No. 54, as a guide for regional and community development.
