WHEREAS, the State of Wisconsin recognizes that Racine County has one public boat launch and recreational small boat basin, that being the Pershing Park Small Boat Basin and Fifth Street Boat Ramp on the shores of Lake Michigan; and

WHEREAS, by way of the State of Wisconsin budget process, Racine County was allocated a Wisconsin Department of Transportation Harbor Assistance Program (HAP) grant in the amount of \$700,000.00, which represents about one half of the total cost of the dredging for the small boat basin; and

WHEREAS, the dredging work will commence in early 2014 and should last for a minimum of ten years, as the last dredging work was done in 2003; and

WHEREAS, the HAP grant will allow Racine County to complete the dredging project, which will provide basin depths more than adequate to accommodate small boats.
