RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH ARAMARK CORRECTIONAL SERVICES TO ALLOW THE FRESH FAVORITES PROGRAM

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that the current 3-year service agreement (Resolution No. 2011-82), between Racine County Sheriff's Office and ARAMARK Correctional Services be amended to allow for the Fresh Favorites Program, is authorized and approved.

BE IR FURTHER RESOLVED by the Racine County Board of Supervisors that the funds received from the Fresh Favorites Program will be deposited as outlined in Exhibit "A" attached hereto, is authorized and approved.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that said contract shall incorporate such terms and conditions as the Corporation Counsel and the Sheriff deem necessary and appropriate.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.

20 **WHEREAS**, the Fresh Favorites Program is an incentive based program currently
21 being used in over 170 facilities nationwide that allows inmates to purchase higher quality,
22 restaurant-style meals on site; and

23
24 **WHEREAS**, the program can be used as a proactive behavior management tool,
25 where the privilege to participate can be taken away based on behavior; and

27 **WHEREAS**, ARAMARK will not be allowed to sell any items that our commissary
28 vendor currently offers; and

30 **WHEREAS**, the County will receive 38% commission from the items sold in the
31 Fresh Favorites Program; and

33 **WHEREAS**, to accommodate the equipment, ARAMARK has agreed to update our
34 natural gas line in the Racine County jail's kitchen, the County will continue to own the gas
35 line; and

37 **WHEREAS**, the gas line project is estimated to have a total cost \$1,700.00, the
38 County will pay the first \$500.00 out of the Fresh Favorites Program commissions and
39 ARAMARK will pay the remaining balance.
