	WHEREAS, in conjunction with the acquisition of highway right-of-way for the
	reconstruction of STH "31", certain severed remnants of land were not conveyed with a land
	sale as part of Lot 1 of Certified Survey Map 1208 (Resolution No. 2003-216), near the
	intersection with Riscavne Ave and new STH "31" in the Village of Mt. Pleasant: and

intersection with Biscayne Ave and new STH "31" in the Village of Mt. Pleasant; and

WHEREAS, the buyer of Lot 1 of Certified Survey Map 1208, paid Racine County the sum of \$1,410,000 in 2004 for 45.09 acres, and is now attempting to develop a vacant portion of

this same land; and

**WHEREAS**, Lot 1 currently has no legal vehicular access point to Old Green Bay Road due to the remnant parcels of land still being in County ownership as a result of a possible surveying error in 2004; and

**WHEREAS**, the Public Works, Parks & Facilities Committee has reviewed the remnant parcels, totaling approximately .792 acres, and has determined that they are of no value to the County, and are no longer necessary for the County's use for highway purposes; and

**THEREFORE**, the .792 acres of land should be transferred to the adjacent landowner, WAB LLC, who purchased the main 45.09 acre parcel from Racine County in 2004, thereby enabling access to Old Green Bay Road (formerly STH 31).
