### RESOLUTION AUTHORIZING RACINE COUNTY COOPERATION AGREEMENT FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

#### TO THE HONORABLE MEMBERS of the Racine County Board of Supervisors:

WHEREAS, this agreement entered into on the 13th day of August, 2012, by and between Racine County and Columbia County; and,

WHEREAS, Racine County has an identified need in the Southern Housing County Consortium to provide decent housing; and,

WHEREAS, Racine County contemplates submitting jointly with Columbia County and the Southern Consortium, an application for funds under the Community Development Block Grant (CDBG) housing program of the Wisconsin Division of Housing (DOH) for the purpose of meeting those needs; and,

WHEREAS, Racine County and Columbia County desire to and are required to, enter into a written cooperative agreement with each other to participate in such CDBG program; and,

WHEREAS, Racine County and the Southern Consortium understand that Columbia County will act as the applicant and will have the ultimate responsibility to assume all obligations under the terms of the grant including assuring compliance with all applicable laws and program regulations and performance of all work in accordance with the grant contract; and,

WHEREAS, it is understood that the Department of Housing and Urban Development and DOH have access to all participants' grant records and authority to monitor all activities.

NOW, THEREFORE, BE IT RESOLVED, pursuant to Wisconsin Statutes 66.0301, Columbia County, the Southern Consortium and Racine County agree to cooperate in the submission of an application for such funds, and agree to cooperate in the implementation of the submitted CDBG program, as approved by the Department of Administration.

Nothing contained in this agreement shall deprive any municipality of any power or zoning, development control or other lawful authority which it presently possesses.

BE IT FURTHER RESOLVED, that Julie A. Anderson shall be appointed to serve on the regional housing consortia board for a two-year term, to be concurrent with the reorganization of the Board of Supervisors.

AND BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the Racine County Clerk is directed to transmit duplicate copies of this resolution by registered mail to Lois Schepp, Columbia County Comptroller, PO Box 473, Portage, WI 53901, within seven (7) days after this resolution is adopted.
