**RESOLUTION BY THE HEALTH AND HUMAN DEVELOPMENT COMMITTEE
AUTHORIZING RACINE COUNTY HUMAN SERVICES DEPARTMENT'S
BEHAVIORAL HEALTH SERVICES TO ENTER INTO CONTRACTS FOR THE
RECEIPT OF 2013 FUNDS**

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that contracts and any contract addenda issued by the various Medicaid, Medicare and private insurance companies are necessary for the Human Services Department's Behavioral Health Services outpatient clinic to receive 2013 insurance payments for clinical services rendered and are, therefore, approved and authorized for execution subject to and pursuant to all of their respective terms and conditions:

1. With any company under contract with the State of Wisconsin to administer Medicaid services.
2. With any company approved by the Federal Government to administer Medicare services.
3. With any private insurance company that provides insurance coverage for mental health and alcohol and drug related clinical services to residents of Racine County

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that contracts and contract addenda issued by the purchasers listed above do not always follow a calendar year. It may be necessary in order to receive 2013 funding that the Human Services Department receive and enter into contracts that may also contain 2014 funding and are, therefore, approved and authorized for execution subject to and pursuant to all of their respective terms and conditions.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the execution of these contracts and any contract addenda shall be subject to the review and approval of the Corporation Counsel and the Finance Director.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the County Clerk, the County Board Chairman and/or the County Executive are authorized to execute any contracts or contract addenda to carry out the intent of this resolution.
