**BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that the transfer and donation of said funds that are collected on behalf of Real Racine to Real Racine is authorized and approved for the purpose of promoting of tourism and recreational and cultural opportunities and to advertise the advantages, attractions and resources of the County.

**BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that as donations are received they will be deposited into account 10560.5245.4342 and monthly revenue transfers are authorized as funds become available. Funds received will be paid to Real Racine at the request of the Public Works and Development Services Department

**BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that the authorization set forth in this resolution shall terminate on December 31, 2015 unless extended by further County Board action.

**BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that all agreements shall incorporate such terms and conditions as the Corporation Counsel and the Finance Director deem necessary and appropriate.

 **BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.
