She also served on several committees including the Judicial Administration Committee, Insurance, Taxation & License Committee, County Administrator's Committee, Courthouse & Sheriff Committee, Anti Pollution Ordinance Committee, Mental Health Clinic Board of Directors, Social Services Committee, Land Use, Agricultural, Environmental & Extension Education Committee, Ethics Board, Executive Committee, Museum Board, Joint Racine City/Racine County Advisory Commission for Disabled Persons, Land Information Modernization & Plan Advisory Committee, Long Term Support Planning Committee for the Community Options Program, Women's Commission, and the Ad Hoc Jail Options Committee, as well as serving on the Lakeshores Library System Board, Secretary of the Gateway Vocational, Technical & Adult Education District Board, and as a member of the Wisconsin County Boards Association and the National Association of Counties; and

WHEREAS, during her tenure as County Board Supervisor, she gained the respect of her colleagues, department heads and her constituents; and

WHEREAS, Ruth R. Gedwardt passed way on April 10, 2010.

NOW, THEREFORE, BE IT RESOLVED, that the Racine County Board of Supervisors stand and pause for a moment of silence in memory of Ruth R. Gedwardt; and
