WHEREAS, the jail wants to start a new program, where the inmates can donate some of their funds to the Jail Chaplaincy Program upon release; and

WHEREAS, there is a need to establish a cost center and budget line in order to accept donations to the Jail Chaplaincy Program; and

WHEREAS, said funds would be utilized to support the programs and sponsor the activities that Chaplain performs on an annual basis and for any programming in the future; and

WHEREAS, the Jail will be using their vendor's commissary software to execute the deposit. They would create a "donation fee" field in the software, so if the inmate wants to donate to the Chaplaincy program the money will be deducted from their account before closing the account. Then the vendor will be sending us the donation fee with the rest of our site fees/commissary commission.

Any funds received from the Community towrds the Jail Chaplaincy Program will be placed into a new account - Donations - Jail Chaplaincy within the Jail's - Jail Commissary.

A Revenue Transfer will occur automatically to a new non-lapsing account - Chaplain Mtls.
