RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE AUTHORIZING ACQUISITION OF A PERMANENT EASEMENT OVER A VACANT PARCEL OWNED BY XTREME UPHOLSTERY, LLC.. PRINCIPAL SCOTT R. PIPER, CONSTITUTING A PORTION OF THE EMBANKMENT ON THE EASTERN END OF THE WATERFORD DAM IN THE VILLAGE OF WATERFORD

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that the acquisition of a permanent easement over a vacant parcel, designated in Exhibit A that is attached hereto and incorporated herein, owned by Xtreme Upholstery, LLC., whose principal is Scott R. Piper, constituting a portion of the embankment on the eastern end of the Waterford Dam, in the Village of Waterford, for the purpose of ensuring the continued maintenance and repair of the dam, is authorized and approved.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors, that the purchase of the easement for one dollar (\$1.00), is authorized and approved.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors, that Corporation Counsel may prepare a contract with necessary and appropriate terms and conditions to facilitate this acquisition;

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors, that any administrative or incidental costs associated with the purchase of the easement, are authorized and approved.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors, that additional terms and conditions may be applicable as the Corporation Counsel, the Finance Director, and the Department of Public Works, deem necessary and appropriate;

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Executive, the County Clerk and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.

WHEREAS, Racine County is the owner of a portion the Waterford Dam located on the Fox River in the Village of Waterford; and pursuant to Ch 31, Wis.Stats., the county is responsible for the operation of the dam, and for the maintenance of the portion of the dam it owns; and,

WHEREAS, a portion of the embankment on the eastern end of the dam, is owned by Xtreme Upholstery, LLC., whose principal is Scott R. Piper (see parcel designated in Exhibit A attached), and who is responsible for the maintenance of that portion of the dam; and,


 WHEREAS, the Wisconsin Department of Natural Resources (DNR) inspected the dam on June 25, 2008, and on September 23, 2008, issued a report identifying repairs and maintenance needed for the dam to improve its structural stability, among them embankment repairs, to be completed, per the report, by October 1, 2010; and,


 WHEREAS, although the county does not presently own the embankment on the eastern end of the dam, the county has determined that it is in its best interest to undertake the necessary embankment repairs during 2011, to ensure the continued safety, integrity, and usefulness of the dam; funding for the repairs is provided in the proposed budget for 2011; and,

WHEREAS, the county has further determined that it is in its best interest to acquire a permanent easement over the parcel, so it can conduct the necessary embankment repairs in 2011, continue to maintain the embankment pursuant to DNR regulations, and have access to the spillway portion of the dam for future maintenance and repairs; and,

WHEREAS, Scott R. Piper has expressed an interest in conveying a permanent easement over the parcel to the county, to allow the county to conduct the necessary embankment repairs in 2011, and to continue to repair and maintain the dam in the future, although Piper has expressed an understanding that he may be responsible for a portion of future repairs and maintenance to the dam, if he continues to own a portion of the dam.
