RESOLUTION BY FINANCE AND HUMAN RESOURCES COMMITTEE AUTHORIZING THE COUNTY TO EXECUTE A "TRI-PARTY AGREEMENT" BETWEEN RACINE COUNTY, RACINE HARBOR MARINA, LLC ("RHM") AND A BANKING INSTITUTION, IN THE EVENT THAT RHM CONTRACTS WITH A NEW BANKING INSTITUTION FOR ITS MORTGAGE NOTE INVOLVING REEFPOINT MARINA

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that Racine County is authorized to enter into a "Tri-Party Agreement" (or similarly titled agreement) with Racine Harbor Marina, LLC (hereinafter "RHM") and a banking institution, concerning financing of RHM's facilities at Reefpoint Marina, in the event that a termination of the current financing arrangement between RHM and Wells Fargo Bank Wisconsin (hereinafter "Wells Fargo") necessitates a new financing arrangement and terminates the current "Tri-Party Agreement" between Racine County, RHM, and Wells Fargo;

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that entry into such Tri-Party Agreement (or similarly titled agreement) is expressly conditioned on there being no change in the substantive terms of the existing Tri-Party Agreement, apart from the amount financed and the name of the banking institution; and

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the Corporation Counsel and Finance Director are authorized to determine whether such Tri-Party Agreement (or similarly titled agreement) effects any change in the substantive terms or the existing Tri-Party Agreement, apart from the amount financed and the name of the banking institution; and

 BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that such Tri-Party Agreement (or similarly titled agreement) may be executed, on behalf of Racine County, by the County Board Chair, County Clerk, or County Executive, or any two of them.
